# Neighborhood Achievement Award

During the recent Neighborhood Conference, the LFNA was awarded a Neighborhood Achievement Award for establishing the Neighborhood Association and for its work with the Dogwood Outdoor Coalition on the hiking trails and outdoor classroom at Dogwood Elementary School. Winners of the Achievement Award were also granted a \$75 gift from the Office of Neighborhoods.

### **Dogwood Elementary**

Kelley DeLuca spoke on behalf of Adam Fritts, who did not attend this meeting due to Spring Break. There was a trailhead cleanup day with Keep Knoxville Beautiful and Americorp Sunday before last.

New fences and gates have been installed around the playground and walking trail. Eventually, they will be locked. Following the Sandy Hook school shootings, Knox County Schools enacted certain security measures for outdoor school play places, and they are now being implemented. At this time, the only way to access the Urban Wilderness trailhead is from Gerson, in the upper left side of the soccer field.

Mr. Fritts asked LFNA to write a letter to Knox County expressing LFNA's displeasure with the fences and asking officials to find some compromise that would allow the neighborhood to access the playground, soccer field and walking trail. The LFNA decided that Kelley DeLuca will write this letter and sign it on LFNA's behalf.

Tonight's meeting is LFNA's quarterly school supplies donation drive.
